- f) the existing use of the land and all immediately adjacent properties, showing buildings, fields, streams, rivers, swamps, wooded areas and areas subject to flooding or erosion.

Subdivision or Consolidation approval happens in 2 steps.	
1. Preliminary Approval	
<ul style="list-style-type: none"> Evaluation of the application by the development officer against the Subdivision and Development Control Bylaw (the Bylaw) Development Officer may escalate evaluation to the council or to a public hearing <p>Simple applications can be processed quickly Larger, or more complicated require more scrutiny</p> <ul style="list-style-type: none"> Once the applicant has obtained a valid Letter of Preliminary Approval, they may apply for a Final Approval Letter of Preliminary Approval is valid for 24 months 	
2. Final Approval	
<ul style="list-style-type: none"> Submit Surveyor-stamped drawings that will be registered to the new parcel(s) when conveyed
